

US Beach Sports LLC – Release of Liability & Assumption of Risk

In consideration of being permitted to participate in beach tennis, volleyball, foot volley, and related activities provided by US Beach Sports LLC, I, the undersigned, acknowledge and agree to the following:

Assumption of Risk:

I understand that participating in beach tennis, volleyball, foot volley, and other related activities involves inherent risks, including but not limited to sprains, strains, bruises, heat-related illnesses, dehydration, and other physical injuries. I voluntarily assume all such risks.

Release of Liability:

I, on behalf of myself, my heirs, executors, and assigns, release and discharge US Beach Sports LLC, its owners, employees, agents, instructors, and volunteers from any and all claims, liabilities, or damages arising from my participation, including those resulting from ordinary negligence.

Indemnification:

I agree to indemnify and hold harmless US Beach Sports LLC and its affiliates from any claims or expenses, including attorney fees, arising from my participation in these activities.

Medical Conditions:

I affirm that I am physically fit to participate and have disclosed any medical conditions that may affect my involvement. I have consulted with a physician as necessary.

Medical Treatment Consent:

In the event of injury or illness, I consent to receive medical treatment deemed necessary. I acknowledge that I am responsible for any associated costs.

Compliance with Rules:

I agree to follow all safety instructions and rules provided by US Beach Sports LLC staff and instructors.

Right to Refuse Service:

US Beach Sports LLC reserves the right to deny participation to any individual at its discretion.

Media Release:

I grant US Beach Sports LLC permission to use photographs or videos of me for promotional purposes, unless I provide written notice opting out.

Environmental Hazards Disclaimer:

I acknowledge that the venue where the activities take place, including Quiet Waters Park, may contain environmental hazards such as rocks, glass, or other debris that could pose a risk of injury. I understand that US Beach Sports LLC is not responsible for the presence of such hazards in the sand or any other part of the venue. I voluntarily assume all risks associated with environmental factors, including injuries caused by these hazards.

Venue Disclaimer:

I acknowledge that Quiet Waters Park and its affiliates are not responsible for any injuries or damages incurred during my participation in US Beach Sports LLC activities.

Governing Law:

This agreement is governed by the laws of the State of Florida. Any disputes shall be resolved in Florida courts.

Severability:

If any provision of this agreement is found unenforceable, the remaining provisions shall remain in effect.
